

## **Prop O Agenda Items on the November 13, 2012 Board Agenda**

### **Castle Park High – Title IX Improvements.**

K-1, page 11 is an amendment to the architectural contract with Lord Architecture, Inc. because of additional fire requirements not in the original scope of work.

M-1 includes a budget increase because of additional DSA and fire requirements.

### **Chula Vista High – Project 1**

M-1 includes a budget reduction for this project because the project is complete.

### **Chula Vista High – ORG Portables**

M-1 includes a budget increase for additional classroom upgrades requested by the site and needed to convert substandard rooms to classrooms.

### **Chula Vista Middle – Project 1 and 6 Portables.**

M-1 includes a budget reduction for this project because the project is nearly complete.

M-2 includes a change order for G.A. Dominguez.

### **Hilltop High – Project 1.**

M-1 includes a budget reduction for this project because the project is complete.

### **iPad Initiative**

M-1 includes a budget increase to partially fund years 2 and 3 of the iPad initiative.

### **Mar Vista High – Title IX.**

K-1, page 8 is a contract for inspection services for Chavez and Associates.

M-1 includes a budget increase for this project because of additional Fire Marshal requirements.

### **Mar Vista High – Project 2.**

M-1 includes a new budget for this project based on the November 2012 list of recommended projects.

**Montgomery High – Project 1.**

M-1 includes a budget reduction for this project because the project is complete.

**Montgomery High – Old Gym.**

M-1 includes a new budget for structural upgrades to the existing gym.

**Montgomery High School Project 2 (Gym . . .).**

M-1 includes a new budget for four years of financing payments.

R-1 is a resolution for the financing mechanism for this project.

**Montgomery Middle School Project 1.**

K-1, page 9 is an amendment to the contract with GHD, Inc for asbestos abatement services required because asbestos containing materials were discovered during construction.

M-1 includes a budget reduction for this project based on satisfactory progress on construction.

**National City Middle – Project 1.**

M-1 includes a budget increase for this project in case it is needed for construction corrections.

**National City Middle – Project 2.**

R-1 is a resolution for the financing mechanism for this project which is already approved by DSA.

**Palomar High – Science.**

M-1 includes a new budget to fund needed science improvements at PAH.

**Proposition O Interest –**

M-1 includes allocation of all available interest to projects.

**Southwest Middle and High – HAR litigation**

K-1, page 10 is an amendment to the contract with Hill International for document processing as requested by the district's legal team.

**Proposition O Performance Audit**

N-3 is the award of the Prop O Performance Audit contract to Nigro & Nigro.
