January 26, 2015 Board Meeting Summary

- Item D-3: **Passed.** In the CFFP update, the Prop O Program budget adjustments included:
 - o The NCM Project 2 budget was increased by \$370,000.
 - A new \$175,000 budget was created to fund ceiling fans at various sites.
 - o The Fire Alarm Upgrade Group 1 budget was decreased by \$100,000
 - o Contingency decreased by \$445,000 and is now 5.0% of remaining expenses.
- Item D-4: Passed. Out of 8 consultant items 1 new contract and 1 amendment pertain to Prop O.
 - o Hire Knowland Construction for inspector-of-record services for the NCM P2 Parking Lot.
 - o Amend the contract with Ninyo and Moore for special testing services at the NCM P2 Parking Lot.
- Item D-5: Passed. Out of 4 change orders 3 pertain to Prop O.
 - o BVM Modernization CO#4 for Fordyce Construction. CO rate is 8.66%.
 - o Tech Infrastructure CO#5 for Standard Electronics. CO rate is 4.38%.
 - o NCM P2 CO#10 for McCarthy Building. CO rate is 8.12%.

- Item D-6: **Passed.** Award construction contract for NCM P2 Parking Lot to Whillock Contracting, Inc. for \$511,236.24.
- Item H-25: **No action taken.** Ratify amendment no. 3 to the Project Agreement for the Montgomery High School Gymnasium Upgrade and Modernization Project, with increased revenue of \$345,732.35 from reimbursement and escrow interest earnings to Proposition O funds.

Issue:

Progress report on the Capital Facilities Financing Plan and approval of new and revised projects and budgets.

Superintendent's Recommendation:

Accept the progress report on the Capital Facilities Financing Plan and approve budget adjustments (BA) for new and revised projects and budgets.

Analysis:

Total current funding for the Capital Facilities Financing Plan (CFFP) is increased to \$654,007,801 with approximately \$189 million remaining to be spent. The CFFP has three groups of projects:

- 1) Proposition O Bond Program which includes closing the remaining Proposition BB projects. Total funding is \$313,019,711 which includes \$187,483,498 from Prop
- O, \$15,574,606 from Prop BB, and \$66,827,452 from County School Facility Fund (state funding);
- 2) <u>CFD Planning Projects</u> (projects that are primarily Mello-Roos Community Facilities District [CFD] funded). Total funding is \$324,257,729, which includes \$269,795,293 from CFD Funds and \$54,342,436 from the County School Facility Fund (state funding); and
- 3) Other Planning Projects (projects primarily funded from other funding sources). Total funding is \$16,730,361, which includes \$9,042,508 from the Special Reserve Fund, \$2,000,000 from CFD Funds, \$3,750,185 from the Capital Facilities Fund, and \$1,262,275 from the County School Facility Fund.

The Proposition O Program budget adjustments include:

BA#1.1 Approve the following budget reductions:

- Decrease Bonita Vista Middle School Modernization budget by \$100,000. The project is complete and remaining funds are for closeout costs.
- Decrease Hilltop Middle School Fans budget by \$41,153. Project is complete and remaining funds are for closeout costs.
- Decrease Fire Alarm Group 3 budget by \$40,000. The project is complete and remaining funds are for closeout costs.
- Decrease Fire Alarm Group 4 budget by \$100,000. The project is complete and remaining funds are for closeout costs.
- Decrease Chula Vista High School Prop BB Growth by \$1,000. The project is closed.
- Decrease Southwest High School Prop BB Project 1B by \$942. The project is closed.
 - BA#1.2 Adjust Southwest Middle School Project 1 budget to account for state disapproval of Quality Education Investment Act (QEIA) funds for this project. The QEIA committee previously approved reinstatement of these funds, but the state has rejected the reinstatement. This requires replacement of the funds with \$412,000 from Prop O contingency for no change to the Project 1 budget. Decrease of \$412,000 to the total Prop O Program Budget.

 BA#1.3 Close and decrease San Ysidro High School Prop BB 1A project by \$25,000. The project was mistakenly identified as having received Prop BB funding. This project is being replaced by San Ysidro High School Project 2 Career Technical Education (CTE) project under Other Planning Projects.
 - BA#1.4 Approve decreasing the Prop O Program contingency by \$128,905 to fund the cumulative project adjustments. Contingency is 6.4 percent of remaining project expenses.

The CFD Funded Project Program budget adjustments include:

- BA#2.1 Decrease the Eastlake High School Restroom Portable budget by \$1,000. This budget was for certification of the existing building. The building is not approveable by the Division of the State Architect (DSA). Replacement of the building is being funded under the current Rehabilitation/Deferred Maintenance project.
- BA#2.2 Approve decreasing the San Ysidro High School Project 2 CTE (Fund 35 portion) project by \$8,586 to close the project. The total CFD Program Project Budget has been increased by \$1,012,141 to reflect the original approved budget plus interest earnings. All but \$8,586 has been spent and this remainder will be transferred to contingency.
- BA#2.3 Increase contingency by \$9,586 to reflect cumulative project budget adjustments.

The Other Funded Planning Projects Program budget adjustments include:

- BA#3.1 Approve a new \$200,000 budget for the Castle Park Middle School Americans with Disability Act (ADA) Hygiene Room. This project replaces a non-conforming hygiene facility needed for special education.
- BA#3.2 Approve a new \$120,000 budget for the Montgomery Adult School Portable project. This project replaces a non-conforming trailer at MOA that was indicated to be removed during the last modernization project.
- BA#3.3 Approve a new \$200,000 budget for Southwest High School Portable modernization project. Portables 902-904 are about 25 years old and need windows, interiors and roofing modernized to continue the life of the building. Replacement would be about double the cost plus the cost of relocating the intermediate data facility (IDF) in room 904 that feeds all of the 900 portables.
- BA#3.4 Decrease the Granger Junior High School Prop BB 1A (Fund 35 portion) budget by \$128,573. This project was completed in October 2005, and is now closed (the project was not closed pending Office of Public School Construction (OPSC) review and now the audit period has passed). The remaining balance can be used for other capital facilities projects.
- BA#3.5 Decrease the Montgomery Middle School Prop BB 1A (Fund 35 portion) budget by \$863,702. This project was completed in May 2006, and is now closed (the project was not closed pending Office of Public School Construction review and now the audit period has passed). The remaining balance can be used for other capital facilities projects.
- BA#3.6 Increase the Sweetwater Union High School Food Services Facility budget by \$350,000 to \$550,000.

BA#3.7 Approve a new \$5,000 budget to certify the San Ysidro High School Project 1 Scoreboard. The budget is for engineering and DSA fees to obtain certification from DSA.

BA#3.8 Increase the SYH 4 ROTC Portables project by \$5,000 to \$5,500. This project has not been certified by DSA and additional budget is required for engineering and DSA fees to obtain certification from DSA.

BA#3.9 Increase contingency by \$112,275 to reflect cumulative project budget adjustments.

Fiscal Impact:

Decrease the Prop O Program budget by \$437,000.

Decrease CFD Planning Projects budgets and increase contingency by \$9,586 for no net fiscal impact.

Increase and decrease various Other Funded Planning Projects project budgets and increase contingency by \$112,275 for no net fiscal impact.

The board also adopted Resolution No. 4141, to become a member of the K-12 Public School Districts and Community Colleges Facility Authority (JPA). The next step was ratification of the agreement with the JPA for the design and construction of the project, which was approved on the October Board Agenda.

This third and final amendment will close the project, return un-used funds withheld for project warranty services, return interest earned in the escrow account, and assign to the district all Agency warranty rights. The returned funds will be used to reimburse the district for costs related to inspection and special inspection services that exceeded the original estimate. In addition, the return of the funds will reduce the County Office of Education Management costs from 7.0 percent of the project cost to 5.4 percent (similar to previous program management project costs of 5.5 percent). The costs were:

- 1) Return of Project Funds: The credit amount associated with this Project of \$345,000 is a portion of the \$22,727,856 Guaranteed Maximum Price (GMP). The final price of the Project was \$22,382,856. These credited funds are hereby removed from this Agreement and will stay with the district and be returned from the escrow account within 30 days of board approval;
- 2) Return of Interest Earned: The interest earned in this account for the duration of the project is \$732, and will be returned to the district according to the contract terms. Payment of this value will be made within 30 days of board approval; and
- 3) Assignment of Warranty Rights: At the request of the district, Agency hereby grants the assignment of all warranty rights. This includes, but is not limited to, the prime contractor's guarantee, as well as all warranties, explicit or implied by subcontractors, material providers, vendors and others on the Project.
